The Mandate of NBACT


NBACT – New Brunswick Association of Counselling Therapists, was incorporated in January 2009. Members of the Association are registered Counselling Therapists who work in a variety of occupations, and who are interested in establishing the statutory regulation of Counselling Therapists in the province of New Brunswick.

The Mandate of NBACT:

- 1. To support and promote the development of legislation to govern the practice of therapeutic counselling by Registered Counselling Therapists.
- 2. To establish and maintain a registration process for members who meet specific educational and experience criteria. Until such time as statutory registration is achieved, our mandate is to regulate the practice of therapeutic counselling in New Brunswick by its members through implementation of a Code of Ethics and

Standards of Practice, and the establishment and maintenance of a professional conduct process for Practitioners.

- 3. To promote public awareness and support for the practice of therapeutic counselling.
- 4. To promote the professional development and provide opportunities for Counselling Therapists. To share information, research findings, viewpoints, and common concerns.

The Road to Legislation Update- The Federation and Progress to Date

Update on the Legislative process in New Brunswick...

After many years of effort on the part of counselling therapists in New Brunswick, the presentation of the Counselling Therapists Act is imminent. The work is being done by an ad hoc committee called the Federation that consists of three representatives from each of the three provincial associations (NBACT, NBPCA, and AFCONB). Legal counsel was retained a year ago and in the ensuing time our lawyer has advised us on numerous revisions to the Act and By-Laws. The revised documents are being translated into French, and while this is happening letters have been sent to key stakeholders to solicit their feedback. Stakeholders have thirty days to respond and once that period has passed, the Federation will advertise the proposed Bill in the province's major newspapers for a brief period. Once these hurdles have been passed, the final step will be the presentation of the Bill in the Legislative assembly. Our lawyer has advised that this could occur in the spring sitting. The presentation of the Bill will represent the culmination of many years of work by many New Brunswick counsellors. Even more than before, however, we need help. Legal fees, advertising and translation are costly and your support and assistance is crucial at this pivotal time. You can get involved by joining one of the three associations. Your membership fees help to counter the expenses incurred by the Legislative process.

What is an RCT anyway?

Great question. RCT stands for Registered Counselling Therapist. All RCT's are registered with NBACT. They have a minimum of a Masters degree in Counselling from an AUCC recognized University, that includes courses in Ethics, Counselling theory, Counselling skills, 2 Counselling electives and 4 additional electives. They also have completed a supervised internship with 120 hours of direct client contact, and have a criminal record check. Wow they sound really smart! Yup, that's because they are! ;-)



NBACT Engages Counselling Students by Jason Jones

NBACT has created two positions for student representatives, one from each of the two AUCC-recognized Master's level Counselling Programs in New Brunswick. Student representatives will act as a liaison with their respective institutions facilitating communication between the University, its students, and the Board of the NBACT.

Jason Jones has been the student representative for the University of New Brunswick for the last 2 years. Jason will be graduating in May 2016 and there will be two vacant positions for both universities.




NBACT website is getting some major traffic. In the past year it has had over 36,000 visitors.
